

Bluegrass Land Conservancy Hunting Tag Raffle

Opening Day Bull's Eye – Tag, You're It! Now is your chance to get an extra shot to benefit Bluegrass Land Conservancy, which is raffling off one (1) hunting tag for each category: Turkey, Deer, or Waterfowl. These Special Commission tags have been awarded to Bluegrass Land Conservancy for the purpose of raising funds for conservation work in Kentucky.

Hunting tags must be used during the 2024 seasons:

Turkey (Spring season runs April 13-May 5)

Deer (Fall season runs September – January 2025 depending on gun or bow style)

Waterfowl (Fall season runs September – January 2025 depending on species)

Raffle ends February 28, 2024 at 12:30pm.

Tickets are \$25 each

No more than 100 tickets will be sold per each category, so act now!

Raffle drawing will occur Live on Facebook February 28 @ 12:30 p.m. EST.

Must be 18 years or older to enter and have or plan on getting an Annual or 1-Day Hunting License. **Winner of the Turkey hunting tag must have a valid 2024 hunting license by February 28, 2024. Winners of Deer and Waterfowl hunting tags must have a valid 2024 hunting license by July 30, 2024.**

Drawing to be conducted live on Facebook at facebook.com/bluegrassconservancy – winners of each category will be announced at that time; there will be only one winner per category. An email receipt for your purchase of raffle ticket(s) will be sent immediately, with a confirmation email to follow once your raffle ticket number has been assigned; physical raffle tickets will not be issued. Receipt and/or transaction numbers should not be confused with raffle ticket numbers; raffle ticket numbers will be posted on our homepage at bluegrasslandconservancy.org, and linked on Facebook once assigned. Raffle ticket numbers are issued and lists updated daily. The winners will also be notified by phone and email no later than February 28, 2024.

The Kentucky Department of Fish & Wildlife (KDFW) issues the hunting permits. For each permit, the BLC is required to submit several items to KDFW. See 301 KAR 5:200, Section 2(11)(d). BLC will provide KDFW with the required:

- hunter's name;
- hunter's address;
- hunter's date of birth;
- a copy of the hunter's 2024 hunting license;

- For waterfowl permits, the requested location and date of the hunt.

The information above has different due dates based upon the permit's species type. **This information must be received by KDFW from BLC by the due date.** See 301 KAR 5:200, Section 2(11)(e).

- **For turkey - March 1st**
- **For deer - August 1st**
- **For waterfowl - September 1st**

Failure to submit the required information to BLC will result in the inability to receive a hunting permit from KDFW. No individual purchase limit applies while sufficient tickets are available; a maximum of 100 tickets will be sold for each category, although actual number sold may be less. Void where participation is prohibited. Refunds are not permitted under state law. All proceeds benefit Bluegrass Land Conservancy, Inc., a Kentucky 501(c)(3) non-profit organization.

Void where prohibited by law. Participants do not need to attend raffle to participate or win.

Drawing may be conducted by staff, volunteer, or board member of Bluegrass Land Conservancy, Inc.; this process will be supervised by BLC's Charitable Gaming Chairperson. Raffle will be conducted in Kentucky, in accordance with all applicable laws and regulations.
